Property Location: The project site is located at 19014 East San Jose Avenue, in the Rowland Heights Community Standards District, within the Puente Zoned District.

General Description of Proposal:

Zone Change No. 201400011-(4) to authorize a zone change from Restricted Heavy Manufacturing - Billboard Exclusion (M-1.5-BE) to Heavy Manufacturing - Development Program (M-2-BE-DP); and

Conditional Use Permit No. 201400135-(4), to authorize the continued operation of an existing recycling center collection facility within the unincorporated community of Rowland Heights. The project is categorically exempt Class 1 - Existing Facilities pursuant to California Environmental Quality Act requirements.
